



## 2020-2021 Rules & Regulations

### Santa Lucia Chapel & Campground, Big Sur, CA

### All Saints' Episcopal Church, Carmel

Santa Lucia Chapel and Campground is truly a sacred space dedicated to providing a place for rest, relaxation, spiritual renewal, worship and fellowship. The parish is pleased to allow its use for non-profit groups, All Saints' Church and School families, and other church groups. **AS THE CAMPGROUND IS PRIVATE PROPERTY, A RESERVATION IS REQUIRED TO ENTER.**

Please note they work "part time," although their available hours are 8:00 AM – Noon and 2:00 PM – 8:00 PM, OR e-mail [Caretaker@AllSaintsCarmel.org](mailto:Caretaker@AllSaintsCarmel.org).** Follow all suggestions made and directions given by the Camp Hosts/Caretakers, who represent the parish in campground matters. To have a safe and meaningful experience, please help maintain cleanliness and safety by observing these regulations:

<b>Check-In/ Check-Out</b>	<b>ALL CAMPERS must check in &amp; out with the Camp Host(s) and submit a signed "Release Form" and "COVID Waiver Form."</b> Please review the checklist at check out. Check-In is from 2 – 6:00 PM. Check-Out from 8:00 – 11:00 AM or by prior arrangement with the Hosts. Arrival time can be no earlier than 2 PM on the first day of your reservation. Departure must be by 11 AM on the last day of your stay.
<b>Liability</b>	<b>It is the responsibility of each group "leader" to send the "COVID Rules," "Release Form" &amp; "COVID Waiver Form" to each camper, asking that they <u>bring their printed, completed &amp; signed forms to check-in.</u> This includes guests visiting your group for the day only.</b>
<b>Parking</b>	Each campsite has limited parking spots: Fireside (8-10 vehicles on SE side); Redwood Knoll (2 vehicles between trees); Paul's Meadow (2 vehicles). Excess vehicles must be parked in either Bay Tree Parking (the small roadway just outside the campground entrance facing Hwy. 1 from Santa Lucia entrance & towards River Inn). Our 2 <sup>nd</sup> overflow parking area, is outside the campground entrance towards the Big Sur Health Clinic.
<b>Vehicles</b>	Motor homes are no longer permitted, as there are no dumping/clean-out facilities and branches are low. No electric generators. No ATVs, sport bikes or motorcycles are allowed.
<b>Capacity</b>	Each campsite has a limited capacity: Fireside (40); Redwood Knoll (40); Paul's Meadow (16) This includes those visiting your group for the day. <b>(Capacity during COVID is 20 instead of 40 and 8 instead of 16, respectively.)</b>
<b>Speed Limit</b>	<b>Speed limit is 3 mph.</b> Please protect our guests by driving slowly!
<b>Chapel</b>	Please be respectful of those using the chapel area for meditation, worship services and/or wedding ceremonies.
<b>Campfires</b>	<b>Campfires are allowed only in established campfire rings. You must bring your own firewood or purchase it locally.</b> Trees and dead wood are protected and may not be cut, gathered, or burned. Your help is needed to preserve Santa Lucia Chapel & Campground's natural beauty! <b>Fires must not be left unattended. <u>Please ensure any fire is fully extinguished when finished with its use! No embers!</u></b>

<b>Smoking</b>	<b>No smoking in campground or within 20 feet of the entrance – Smoking is allowed on the asphalt only!</b>
<b>Cooking</b>	Charcoal fires are permitted only in the free-standing portable grills or in the Santa Maria barbecue pit (in and for the Fireside camp site only). Camping stoves are permitted, but their use is restricted to the eating area near the individual picnic tables. <b>Always allow grease to set until firm and place it in the trash. NO grease poured down the drain of the sinks – in the camping areas or restrooms - ever!</b>
<b>Tables</b>	Picnic tables are spaced for social distancing during COVID and are not to be moved. Period.
<b>Trash</b>	For your convenience a dumpster, blue recycling bins and an aluminum can/plastic drink container are located on the right before you enter Santa Lucia Campground. <b><u>You are responsible for sorting trash (crushing drink bottles, cans and other recyclable), in the bins AND for placing your trash bags inside the dumpster and recycling bins.</u></b> Before leaving, please check your campsite for any remaining trash. <b>You must take discarded packaging and broken equipment home with you. They are NOT to be left in the campground.</b>
<b>Safety / Swimming</b>	<b>An adult must be in the water to supervise swimming or rafting with children 12 and under. Children should never be left unsupervised. No one should swim alone.</b> Aqua shoes are recommended for those who walk or raft in the river. Campers are permitted to use inner tubes in the river, but you must provide your own or rent one locally. <b>Rock throwing – in or out of the river is not allowed.</b> Doing so could result in being asked to leave the campground and loss of camp fee or security deposit (large groups).
<b>Restrooms</b>	Please help maintain the cleanliness and function of the washrooms. ONLY flush toilet paper down the commodes. Please use the trashcans for feminine and additional paper products. Restrooms are cleaned numerous times each day. Please be mindful of paper towel consumption.
<b>Quiet time</b>	Please maintain silence and respect for all other campers between the hours of 10 p.m. & 8 a.m. Even soft voices are amplified across the water to the campers on the other side of the river, who observe the same quiet hours.
<b>Amenities</b>	Fresh drinking water and bathrooms are available. <b>Please be advised that there is no hot water or showers.</b> It is absolutely forbidden to use the showers in the campground across the river. Only one person at a time allowed in each restroom during the Pandemic.
<b>Alcohol</b>	<b>All Groups must observe the Diocesan Alcohol Policy (see enclosed). Hard liquor is not permitted.</b> Abuse of beer or wine will result in being asked to leave the campground and/or refusal to the grounds on future occasions as well as loss of your security deposit (large groups).

<b>Animals</b>	<b>Dogs should be on leashes or in kennels and should stay in their respective campsites. They cannot be left unattended at any time.</b> Cats and other animals should be kept caged. Horses are not permitted. Owners are responsible for cleaning up after their pets. <b>Be aware that there can be skunks in the area at night. Do not disturb them and they will not disturb you.</b>
<b>Supplies/All Saints' Equip.</b>	While we supply trash bags and the basics in the restroom, we hope that you will be frugal in using them. <b>Use paper towels, etc., sparingly. Equipment belonging to the campground is to stay at the campground.</b>
<b>Poison Oak</b>	Big Sur and Santa Lucia has their fair share. Please stay clear of it.

<b>Weapons</b>	No weapons of any kind are permitted on the campground – ever!!
<b>First Aid</b>	<b>Please bring a suitable First Aid Kit.</b> When open, the Big Sur Health Center may be a valuable resource.
<b>Emergencies</b>	<p><b>EMERGENCY services, call 911.</b></p> <ul style="list-style-type: none"> <li>Your specific location is <i>Santa Lucia Campground and Chapel, 46896 Highway 1, Big Sur, CA 93920.</i></li> <li>The phone number for the campground is <i>(831) 667-2310.</i></li> <li><b><u>If you have a problem that requires emergency services (medical, fire, or police), be advised it will take upwards of ONE HOUR for them to arrive on site.</u></b></li> </ul>
<b>Electrical Power</b>	<p>Despite the primitive camping and beautiful natural surroundings, electrical power is VERY important at Santa Lucia. It runs both the water and sewer systems. If power is lost, the water and sewer systems will run for a while but will eventually degrade and fail. A good metric to determine how long the power can be out before things get critical: The bathrooms can support around 50 toilet flushes without power, after which they will back up and not be usable. <b>A fee of \$10 per day will be charged for excessive electrical use.</b></p> <p><b><u>It is CRITICAL that, IF THE CAMP LOSES POWER FOR MORE THAN AN HOUR, you contact the Camp Hosts (1-831-667-2310).</u></b></p>
<b>Wi-Fi Access</b>	There is a Guest WIFI network that can be accessed in limited areas. Please ask the Camp Hosts how to access it.
<b>Cell Phone Access / Texting</b>	Cell phone coverage at Santa Lucia is spotty at best and completely non-existent at worst. However, if you have cell service with AT&T, you <u>may</u> be able to get reception. Texting may be possible. Ask the Camp Hosts for details.
<b>Clean up</b>	Please check your campsite and leave it without debris. Then <u>check out with our Camp Hosts</u> (large groups must go over the checklist and retain your security deposit).
<b>Security Deposit</b>	<b>Groups over 40 must submit a \$300 check to the Camp Host(s) along with Release Forms upon Check-In. Check-Out with Camp Hosts to verify the campsite is left in correct form. The Security Deposit check will be returned upon Check-Out if warranted and agreed upon by Camp Hosts.</b>
<b>Departure</b>	Please check out with the Camp Hosts. Ensure everything is cleaned up before you leave.
<b>Form of Intention</b>	We ask that you mark or state the intention for your campout on your Reservation Form.

Please enjoy the beauty and serenity of Santa Lucia,  
God's gift to us all.

**Your initial deposit of 50% of your campsite's base fee(s) reserves your campsite, so please remit it right away with the Reservation Form. The last 50% is due 30 days prior to your camping date.**
